1. Eligibility criteria for participation in tender :

The intending tenderer will have to produce the following information / data / credentials / certificates etc. to the undersigned along with the prayer for obtaining the tender form to participate in the tender.


- Self attested Copy of PAN Card with latest Income Tax return.
- Self attested Copy of the GST clearance certificate with latest return as applicable.
- Self attested Copy of the Professional Tax clearance certificate with latest P. Tax Challan.
- Self attested Copy of valid Trade License.
- Self attested copy of completion certificate with work order of at least 40% of estimated value of related specific works. Payment certificate will not be treated as Credential.
- Additional performance bank guarantee: Additional performance security has been mandatory which shall be obtained only from the successful L1 bidder, if the accepted bid price is below by more than 20% of the amount put to tender, this additional performance security shall be equal to 10% of the awarded amount.
- In case of Electrical Works, valid Electrical contractor's license with electrical supervisor license and registration certificate is mandatory.
- Delivery and installation to be done at Nistarini College, Desh Bandhu Road, Purulia by the consignor at their own cost.
- Three months or one year or three years or five years, as the case may be (depending upon the nature of the work as described in the explanation appended hereto) hereinafter referred to as the Defect liability period as per order no.5784-PW/L&A/2M-175/2017 dt.12.09.2017.
Original documents as mentioned above should be produced before the undersigned for verification before the issue of the Tender Form as well as before acceptance of tender by the authority.

- The acceptance of the tender will rest with the accepting authority who does not bind himself/herself to accept the lowest offer or all tenders received and to split up the work without assigning any reasons thereof.

4. Constructional Labour Welfare Cess @ 1(one)% of cost of construction will be deducted from every progressive bill; GST, & all other Statutory levy / Cess as applicable will have to be borne by the contractor & the rate quoted by them should be inclusive of all the taxes, cess & charges etc.
5. **Earnest Money:** 2% of the estimated value as mentioned in the NIT for each of the work to be submitted in the form of Demand Draft or Banker's Cheque payable in favour of "**Principal, Nistarini College**". Tender will be declared informal if Earnest Money is not submitted.
6. **Security Deposit:** Balance amount of security deposit will be deducted from each and every progressive bill to make 10% security deposit as per terms of the contract.
7. No exemptions are admissible for labour cooperative.
8. Contract documents consisting of specifications, terms and conditions for the work and the condition of the contract as laid down in W.B.F-2911 need to be complied with by the tenderers.
9. No **conditional / incomplete tender** will be accepted under any circumstances.
10. The Principal, Nistarini College, Purulia reserves the right to cancel the NIT due to unavoidable circumstances and no claim in this respect will be entertained.
11. During scrutiny, if it comes to the notice of the authority that the credential or any other papers submitted are found incorrect / manufactured / fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
12. The undersigned reserves the right to accept or reject any/all bids / quotations and to cancel the bidding process without assigning any reason whatsoever.
