

He/ She is hereby appointed, on purely temporary basis, to the post of Excise Constable under the Durgapur Excise Division, West Bengal in the Scale of pay, i.e., Pay Matrix Level-6 (Rs. 22700/- to Rs. 58500/-) as per West Bengal Services (Revision of Pay and Allowance) Rules, 2019 plus usual allowances as admissible under the existing rules subject to the following conditions, viz:

1. That he/ she submits for the purpose of entry into the Government Service a declaration of his/ her age in prescribed form (obtainable from the office) along with the documents from the appropriate authority showing his/ her date of birth in support of his/ her declaration;

That he/ she submits within a period of 3(three) months from the date of his/ her joining in the post of Excise Constable, his/ her first return showing his/ her assets as they stood on 1<sup>st</sup> January 2022/ or his/ her year of joining and shall thereafter submit such statement every year within stipulated date as per existing rules;
5. That he/ she shall be liable to be transferred anywhere in the State of West Bengal as and when necessary in the interest of public service;
6. That he/ she shall undergo police training at such institute and for such period as may be fixed by the appropriate authority;
7. That no travelling expenses will be allowed for his/ her journey to join the post of Excise Constable.

Upon Observance of the aforesaid conditions and/ or submission of documents, as aforesaid, he/ she will report to the Superintendent of Excise, Purulia under Durgapur Excise Division immediately.

### **Admission to the Integrated Bachelor's-Master's Program in Science - 2022**

IACS is conducting a de novo five-year Integrated Bachelor's and Master's Program in Science for highly motivated students who have passed (10+2) level Examination in science stream. The objective of this program is to provide high-quality education, research, and training in science. Through this special program, undergraduate teaching is integrated with modern research in all major Schools of the Institute. The first three semesters of the program will comprise foundational courses in Physics, Chemistry, Mathematics, Computer Science and Biological Sciences. From the fourth semester onwards, the students will choose one discipline (from Physics, Chemistry, Biological Science, Mathematics and Computer Science) as majors, subject to fulfilling eligibility criteria and availability of seats in the respective Schools. From the seventh semester the students will be directly exposed to research.

### **Admission to the Master's/Integrated Master's-Ph.D. Program in Science - 2022**

Applications are invited from highly motivated Indian nationals for admission to the Master's/Integrated Master's-Ph.D. Program in the Schools of Chemical Sciences, Physical Sciences, Materials Sciences, Mathematical & Computational Sciences, Applied & Interdisciplinary Sciences for the session likely to begin from August 16, 2022. Candidates who are due to complete their Bachelor's level University Examinations are eligible to apply but their final selection will be subject to securing 60% marks (reservation criteria will apply as per rules) in the qualifying examination. Candidates having Engineering background and opting for School of Mathematical & Computational Sciences should have adequate training in Mathematics and Computer Science. Eligible applicants will be required to appear for a Master's Pre-Interview Screening Test (MPST). MPST-2022 will be conducted in a fully computer-based test mode on tentatively on July 02, 2022 in various cities across India on multiple choice questions on the subject depending upon the choice of School. Candidates shortlisted on the basis of the written test will be called for interview, out of which a maximum of twenty (20) candidates will be selected for admission in each of the Schools. Actual intake in a particular school will depend of the performance of the candidates in MPST and interview. Admitted students may be eligible to receive a stipend of Rs. 12,000/- p.m. (fixed) for the first two years, provided that they fulfill the prescribed CGPA and other criteria in the final examination of their first semester. On successful completion of the Master's course, the students satisfying criteria to be prescribed by the Institute will be considered for admission to the Ph.D. program as Integrated Master's-Ph.D. students, to whom Junior Research Fellowship will be awarded as per the prevailing norms, provided they meet the criteria of national eligibility. Admission under the reserved categories, including EWS will be as per rule. Applications for Integrated Bachelor's-Master's and Master's/Integrated Master's-Ph.D. Program are to be made online. The online application portal will be live tentatively in the second week of May 2022. There is a non-refundable application fee of Rs. 1200 (Rs. 600 for SC/ST and PD candidates only).
