1. Do you take classes regularly?

Interpretation of the Feedback:

The feedback shows that a majority of the teachers take classes regularly (more than 90% of the classes). Eleven teachers have reported that they take more than 80% of the classes. These teachers could not take their classes because of leave or illness.

Action Taken by the college:

The college first took note of whether all the teachers had completed their stipulated syllabus. If some teachers had not completed their part of the syllabus, these teachers were requested to take extra classes online to complete the syllabus.

2. Do you complete the syllabus timely?

Interpretation of the Feedback:

As per the above question, most of the teachers reported that they had completed the syllabus. 8 teachers reported that they had completed most of the syllabus, but not completely, because they had been ill or on leave.

Action Taken by the college:

The eight teachers who had not completed the syllabus were requested to complete their syllabus by taking online classes.

3. Do you conduct question and answer sessions with the students?

Interpretation of the Feedback:

Of the 74 teachers who had submitted the feedback, 49 teachers have held question and answer sessions with the students always, and 17 teachers have frequently held such sessions. 8 teachers say that they have held such sessions as per requirement. It shows that all the teachers hold question and answer sessions with the students in the classrooms.

Action Taken by the college:

As it is found that almost all the teachers normally take question and answer sessions, no action was required in this case.

4. Do you take class tests regularly?

It was seen through the feedback that all the teachers take class tests in one form or the other.

Action Taken by the college:

As it is found that almost all the teachers normally take class tests, no action was required in this case.

5. Do you provide class notes to the students?

Interpretation of the Feedback:

The feedback shows that almost all the teachers provide class notes to the students continuously, or as per requirement. Only one teacher has reported that s/he does not provide class notes. Though the picture is positive, it is the policy of the college that all the teachers will have to provide class notes for better understanding of the lectures.

Action Taken by the college:

The teacher who had not provided class notes was called up by the Principal, and was requested to conform to the norm.

6. Do you use ICT facilities?

Interpretation of the Feedback:

From the feedback it is found that most of the teachers use ICT facilities for teaching. A small number does not use such facilities. This is not approved by the college.

Action Taken by the college:

In one of the all-teachers' meetings, the Principal spoke to the teachers about the need to use ICT facilities while teaching, and reiterated the point that these facilities will certainly increase the quality of the teaching. She told the Computer Science department to help any teacher who finds it difficult to use these facilities.

7. The institute takes active interest in promoting internship, student exchange, field visit opportunities for students.

Interpretation of the Feedback:

It is found from the feedback that almost all the teachers avail of library facilities, either from the Central Library, or the Departmental Library. Only one teacher has reported that s/he does not avail of the library facilities regularly.

Action Taken by the college:

The Librarian conducted a Power Point presentation for the teachers, informing them of the library facilities available in the college, and how these can be accessed. The teachers were informed that they are free to use both physical books and e-books and journals. All teachers were requested to use the facilities more often, and also inform the students about the facilities available.

8. What is your opinion about library facilities?

Action Taken by the college:
