



(d) After successful delivery of two seminar presentations on the research work , you will be required to apply to the Registrar together with the Supervisor's certificate for granting you the permission for submission of the thesis. You may submit your thesis for adjudication within a period of six months from the date of pre-submission seminar presentation.



(e) You will have to submit your thesis with the office of the Registrar within six years from date of your enrolment/admission to Ph.D. programme in this University in the current session or within five and a half years from the effective date of Registration to Ph.D. Programme (applicable if Course Work is from other Institute or for any interim-period Ph.D. registration in some casual vacancy ) ,but not earlier than three / two and a half years i.e. ....02/09/2024..... in the prescribed manner along with the fee of Rs 17000/- plus necessary postage or a fee as may be fixed by the Executive Council from time to time towards submission of thesis.

You will also be required to submit six copies of Synopsis/abstract of the thesis (normally in not more than five thousand words) along with the thesis. While the thesis is submitted in regional language for language subjects, the synopsis is also to be translated in English language.

(j) At the time of submission of the thesis you will have to produce a certificate from the HOD of the concerned Department regarding presentation of two pre-submission seminar lectures and the Clearance Certificate from the Librarian of the University and from the respective Department.
