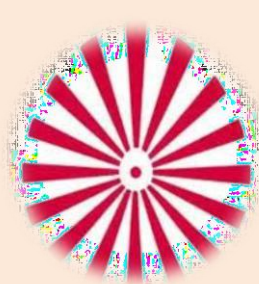

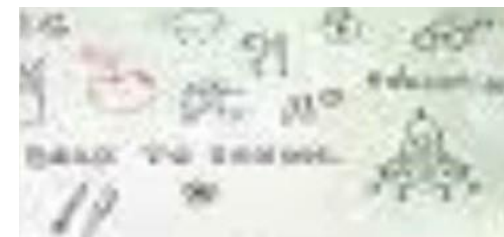

NbS are practices and strategies that work with nature to address climate adaptation and mitigation challenges, while bringing long-term benefits for people and ecosystems. In the Decade on Ecosystem Restoration, deployment of NbS has received significant attention as a promising strategy to address societal and environmental challenges. The recently concluded CoP26 highlighted the co-benefits generated from NbS to address the global crisis of biodiversity loss and help achieve the Sustainable Development Goals. Yet, according to the United Nations Environment Programme (UNEP), globally, investments in NbS need to triple by 2030.

Agricultural land and forests comprise 70% of India's total land area and 15% of India's greenhouse gas emissions, which means they provide an immense opportunity for NbS. In addition, they support over 700 million Indians in the form of livelihoods or sustenance – especially those communities that are highly vulnerable to the impacts of land degradation, biodiversity loss, and climate change. NbS can also create significant job opportunities in India, with the World Economic Forum forecasting the potential of NbS to deliver \$3,565 billion of annual business opportunities and 191 million jobs by 2030.

The ICC aims for NbS to be implemented at scale in India and become mainstream; however, there is a need to close the existing knowledge and financial gaps that may impede its uptake. This session will bring together land-use actors to discuss the opportunities and challenges to scaling up NbS in India; get insights and perspectives on how best unlock, mobilise, and catalyse finance for nature from the private and public sector in India; and inspire the funding community to support credible and ambitious scale-up of effective NbS as part of 1.5 degrees, climate-resilient pathways.

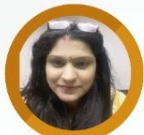

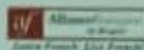
