1. Photocopy of the PAN Card.
2. Photocopy of latest income Tax Return Certificate.
3. Photocopy of valid Trade License.
4. Photocopy of Profession Tax Clearance Certificate with latest P. Tax Challan.
5. Photocopy of GST Registration Certificate.
6. Photocopy of Completion certificate and schedule of at least 40% of the value of credentials of related specific works or similar type of works within last 3 (three) years.
7. No incomplete / conditional prayer will be accepted under any circumstances.
8. Additional performance security has been mandatory which shall be obtained only from the successful L1 bidder, if the accepted bid price is below by 20% and above of the amount put to tender, this additional performance security shall be equal to 10% of the tendered amount.
9. Constructional Labour Welfare cess, GST, Royalty and all other Statutory levy / cess as applicable will have to be borne by the contractor(s) as per Govt. rule.
10. In case of Electrical works **valid Electrical contractor's license with electrical supervisor license with detailed part and registration is mandatory.**
11. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other papers submitted are found incorrect / manufactured / fabricated, that bidder will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
12. No store room or godown be provided to the working agency.
13. Electricity if required charges be paid by the working agency as per the reading of Sub-Meter.
14. No water will be provided for civil works due to scarcity of water in the college campus.
15. Working hours: 9.00 am to 5.00 pm. No staff of working agency be allowed in the college campus beyond working hours.
