IACS is conducting a de novo five-year Integrated Bachelor's and Master's Program in Science for highly motivated students who have passed (10+2) level Examination in science stream. The objective of this program is to provide high-quality education, research, and training in science. Through this special program, undergraduate teaching is integrated with modern research in all major Schools of the Institute. The first three semesters of the program will comprise foundational courses in Physics, Chemistry, Mathematics, Computer Science and Biological Sciences. From the fourth semester onwards, the students will choose one discipline (from Physics, Chemistry, Biological Science, Mathematics and Computer Science) as majors, subject to fulfilling eligibility criteria and availability of seats in the respective Schools. From the seventh semester the students will be directly exposed to research.

Admitted students entering into the fourth year may be eligible to receive monthly stipend, following the institute norms. Admission under the reserved categories, including EWS will be as per rule.

Admission to the Master's/Integrated Master's-Ph.D. Program in Science - 2022

Applications are invited from highly motivated Indian nationals for admission to the Master's/Integrated Master's-Ph.D. Program in the Schools of Chemical Sciences, Physical Sciences, Materials Sciences, Mathematical & Computational Sciences, Applied & Interdisciplinary Sciences for the session likely to begin from August 16, 2022. Candidates who are due to complete their Bachelor's level University Examinations are eligible to apply but their final selection will be subject to securing 60% marks (reservation criteria will apply as per rules) in the qualifying examination. Candidates having Engineering background and opting for School of Mathematical & Computational Sciences should have adequate training in Mathematics and Computer Science. Eligible applicants will be required to appear for a Master's Pre-Interview Screening Test (MPST). MPST-2022 will be conducted in a fully computer-based test mode on tentatively on July 02, 2022 in various cities across India on multiple choice questions on the subject depending upon the choice of School. Candidates shortlisted on the basis of the written test will be called for interview, out of which a maximum of twenty (20) candidates will be selected for admission in each of the Schools. Actual intake in a particular school will depend of the performance of the candidates in MPST and interview. Admitted students may be eligible to receive a stipend of Rs. 12,000/- p.m. (fixed) for the first two years, provided that they fulfill the prescribed CGPA and other criteria in the final examination of their first semester. On successful completion of the Master's course, the students satisfying criteria to be prescribed by the Institute will be considered for admission to the Ph.D. program as Integrated Mastér's-Ph.D. students, to whom Junior Research Fellowship will be awarded as per the prevailing norms, provided they meet the criteria of national eligibility. Admission under the reserved categories, including EWS will be as per rule. Applications for Integrated Bachelor's-Master's and Master's/Integrated Master's-Ph.D. Program are to be made online. The online application portal will be live tentatively in the second week of May 2022. There is a non-refundable application fee of Rs. 1200 (Rs. 600 for SC/ST and PD candidates only).

The tenure of fellowship is five years and it commences from the date of declaration of NET result, i.e., 05.11.2022 (or) from the date of admission under M.Phil/Ph.D. (or) from the date of joining M.Phil/Ph.D. programme, whichever is later. The summary of financial assistance offered under the scheme is mentioned at Annexure I available on www.ugc.ac.in/netjrf

The Awardee is required to get admission and registration for regular and full time M.Phil./Ph.D. course in a University/Institution/College recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. University/Institution/College is requested to process for award of JRF based on this letter, in accordance with the procedure available on www.ugc.ac.in/netjrf.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the Awardee (any bank) directly. UGC has developed a dedicated web portal (https://scholarship.canarabank.in) for capturing data of the awardee. The Universities/Colleges/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker/Checker Ids which have already been provided to them along with the passwords. The Universities/Colleges/Institutions shall update the information in the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Colleges/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).
